Pipe Markers

THE SIGNS OF A SAFE INDUSTRY



Our pipe markers comply to all recommendations outlined in ANSI Standard A13.1-1966 that pertain to marker code, marker length, color of wording and size of wording.

Materials



Identify pipes throughout the building by peeling off the backing and applying pressure to the vinyl surface for a fixed seal. Designate the direction of flow in the pipe using **Directional Flow Arrow Tape** found on page 97.

Labeling Pipes

- Pipe markers should be placed near all valves or flanges, next to areas where pipes shift direction or go through walls and floors.
- All Pipe markers should be placed on the lower side of the pipe if workers need to look up to see pipe and on the upper side of pipe if workers need to look down or placed directly facing the worker if pipe is eye level.
